2. Who Qualifies

• To qualify, a Hosted Buyer should stay at the event at least 2 days and hold a minimum of 6 verified meetings with CPHI / Hi KOREA 2024 exhibitors

3. A Hosted Buyer will be committed to

 Attend the event and hold at least 6 verified meetings with exhibitors during at least 2 days of staying at CPHI / Hi KOREA 2024

- Hosted Buyers should schedule their meetings via Online Matchmaking Platform in advance (The login details will be sent from the organiser)

- Hosted Buyers should submit at least 6 meeting reports during and after the event
